- 1. Minutes Approve from 1/10/24 Meeting

- 2. Treasurer Report -
  - Checking Account Balance: 2718.58 Checking;
  - Grant Co Deposit has been paid since last meet
  - \$1500 Owed on 2<sup>nd</sup> and 3<sup>rd</sup> place awards
  - Received preliminary 2024 budget Discussion
    - If bring in all that is budgeted we have enough to put on PNWIC but will use up the reserve we had at beginning of this year.
    - Some things were paid in 2023 by OHSET and did not charge back to PNWIC paid to put on PNWIC but PNWIC did not pay it
    - Stall cleaning is built into PNWIC paying for stall cleaning... \$18 per dirty stall is charged back and already built into the budget.
    - This year PNWIC will pay judges meals but will not pay for committee members
    - EMT on site is a judgment call... if 3-5 minutes of emergency response don't need on site; it is currently not in budget because on call is close enough
    - o Jackpot fees will be \$15; PNWIC will keep 30%
    - Motion made and seconded to approve the budget... voted and approved
    - Denise will resend budge taking out the rodeo arena will add to bottom line





#### 3. 501c3 Discussion for PNWIC

- May be easier to get sponsors if we are an entity of our own without the confusion to sponsors. Brandon will put together by-laws and start the ground work to get this process started. PNWIC does not have the funding to make this happen right now but if we have own tax base.
